## Terms of agreement

- The seller hereby provides the buyer with \_\_\_\_ doses of frozen semen – non refundable 850 USD per dose – for the artificial insemination of the mare described. A minimum of two doses is recommended.
- Quality of the frozen semen has been approved by the Centre de reproduction équine Transbio, upon the following criteria: each dose containing a minimum of 300 million total sperm and showing at minimum a 30 % post-thaw progressive motility.
- The frozen semen is proven fertile.
- Buyer is responsible for all shipping, tank rental and handling fees associated with delivery of the semen from the storage facility and return of the shipping container within delays agreed upon. Semen is stored and prepared for shipping by the Veterinary Medicine Faculty of St-Hyacinthe. The buyer must provide a 24 hour notification for preparation of semen.
- FedEx shipment will be arranged by seller, **Monday through Thursday**, in order to avoid delays on week ends. No shipments on Holidays.
- Buyer is responsible, if rental of DryShipper is needed, to insure return of tank back to the Veterinary Medicine Faculty of St-Hyacinthe within delays agreed upon.
- Seller is not responsible for any trouble related to semen shipments - delays in delivery such as missed flights, weather delays, failure of third-party service, or acts of God, resulting in loss of viability of the semen. Insurance is highly recommended. Buyer is responsible for additional insurance fees.
- It is also the buyer's responsibility to make sure all importation requirements are met. Seller is not responsible for any custom caused delays.
- There is NO live foal guarantee offered with this contract.
- All sales are subject to availability and are final upon acceptance of this Agreement. All fees are payable upon execution of this Agreement. Buyer specifically agrees and understands that no semen will be shipped until all fees have been paid (by check or electronic transfer).
- The artificial insemination must be executed by a veterinarian familiar with the procedures concerning equine reproduction and the manipulation of frozen semen. A breeding report will be sent to the owner of the mare. The sections "Breeding soundness" and "Insemination" must be signed by the veterinarian and sent to stallion's owner.
- Seller makes no guarantees or warranties, expressed or implied as to the fertilizing capacity of any semen provided under the terms of this Agreement. However, the conception rate will be provided to the seller upon request.
- A breeding certificate from the Friesian Sporthorse Association will be issued upon request and sent to the buyer upon notification of the birth of the foal. Buyer is responsible for compliance with registry requirements and payment of any fees for the subsequent registration of foals conceived.
- Buyer is responsible for compliance with registry requirements for the use of frozen semen and payment of any fees for the subsequent registration of foals conceived.
- A copy of the registration papers as well as a picture of the mare must be sent to the stallion's owner along with the signed agreement.
- Any change on this contract (buyer, mare, etc.) must be agreed upon by both parties.
- This contract is not transferable by neither of the parties.
